## **Call for Submission of Global Alliance Online Marketplace Snapshots**

Dear Global Alliance Members,

As communicated during our recent Townhall meeting, we are pleased to launch the first **regular call** for the submission of **project snapshots** to the **Global Alliance Online Marketplace**.

The <u>Online Marketplace</u> serves as a repository of collaborative project proposals from Alliance members working to advance the Alliance's vision. It seeks to connect donors interested in supporting statelessness work with impactful initiatives, providing a convenient 'one-stop shop' where donors can quickly review project snapshots for potential funding, thereby, attracting additional support for this area of work.

It enables organizations to do a first pitch to interested donors before embarking on more detailed proposals - a challenge for smaller grassroots civil society organizations and others with limited capacity.

Please note that inclusion in the Online Marketplace does not guarantee funding; it serves to promote visibility and potential donor engagement.

We encourage the submission of snapshots, aligned with the criteria outlined below and in the attached Online Marketplace **Terms of Reference (ToRs).** 

### **Eligibility**

The lead organization submitting a Marketplace snapshot must:

- ✓ Be a member of the Global Alliance.
- ✓ Represent a civil society organization, a stateless-led group, or an academic institution.
- ✓ Work on statelessness or equal nationality rights, or demonstrate a clear commitment to these issues.

Co-leads and contributors may include non-members and representatives from stakeholder groups beyond those listed above.

Each eligible organization may submit one project snapshot per call, unless specified otherwise.

# **Criteria for Marketplace Snapshots**

- ✓ Respond to Statelessness: Your project should contribute to addressing and preventing statelessness, and/or protecting stateless persons. Proposals can cover new initiatives or reinforce your organization's ongoing efforts.
- ✓ Align with Global Initiatives: Clearly indicate how your project is aligned with the Global Action Plan to End Statelessness 2.0, and support the Sustainable Development Goals (SDGs). Please also specify if the activities contribute to the implementation of Global Refugee Forum (GRF) pledges.



- ✓ **Support for Solutions**: Indicate how your project will contribute to developing and/or implementing initiatives for sustainable solutions, and/or prevention and protection of stateless persons, in line with the Global Alliance's vision.
- ✓ **Sustainability or Link to Longer-Term Strategy:** Projects should contribute to the longer-term goals and strategy of the organizations. Proposals should demonstrate how the activities will have a lasting impact beyond the project period.
- ✓ Advancing Collaborative Approach: Projects should ideally engage members of the impacted communities, and/or other relevant stakeholder groups (such as academia, civil society, regional organizations, or States), either as co-implementers, contributors or beneficiaries.

#### **Process**

Each project snapshot should indicate its expected implementation period - short-term (under 6 months), medium-term (6–12 months), or long-term (over 12 months) - and specify the estimated funding need within one of the listed ranges – with a maximum ceiling of USD 100,000.

Following pre-screening by the Secretariat, eligible snapshots are listed on the public Online Marketplace for six months to enhance donor visibility and review or, if preferred, placed in the offline repository for direct pitching to donors. Extensions of the listing period may be considered on a case-by-case basis.

If a donor expresses interest, the Secretariat facilitates initial contact with the project lead. Donors may request a full proposal or additional documentation and apply their own due diligence and eligibility criteria before approving funding.

The Secretariat does not influence donor decisions, and inclusion in the Marketplace does not imply endorsement or guarantee funding.

### **Submission Process**

- Deadline: 1 November 2025
